## A curious lack of corpses. A slew of snobbish suspects. Can this sightless amateur sleuth pinpoint a killer?

Dallas, TX, 1930. Daiyu Wu refuses to be disadvantaged by her blindness. Navigating the world with help from her faithful companions, the young Chinese adventuress celebrates life with a strong thirst for knowledge. So when she scents burned garlic in a customer's garment, the clever laundress runs an experiment that reveals a dress doused in arsenic.

Determined to provide the unaware authorities with a clue in a murder case, Daiyu vows to chase down the garment's mysterious origins even though there's no body to be found. But as the links lead the immigrant girl higher into Texas's social echelons, she clashes with bigotry, short-sightedness, and a web of lies hamstringing her ability to investigate.

Can she find fresh evidence before she's hung out to dry?

#### A socialite accused of murder, planted evidence, and mysterious enemies challenge blind detective Daiyu Wu in her new sleuthing adventure.

When a highly respected member of the 'Little Mexico' community is killed in 1930 Dallas, all the evidence points towards Grace Pierce, wife of a local businessman and a former member of the Ku Klux Klan. Grace's son Truman turns to Daiyu Wu and her unique detective skills for help, but Dai quickly discovers that nothing about this case is what it seems.

With her companion Jacques and canine bodyguard Prince Razor, Dai must navigate a family in turmoil, racial tensions, and shady business deals to find the actual killer before Truman's mother is sentenced to death.

# A suicide that wasn't. Racial prejudice pushing a murder to be swept under the rug. Can Daiyu Wu throw back the covers to reveal the killer?

Dallas, TX, 1930. Daiyu Wu resigned herself to life inevitably returning to normal after dipping her toes into the pursuit of justice. But a new case falls onto her lap when she hears screeching tires and a woman calling out in pain. The older lady is wary of her offer to help, but Daiyu knows people aren't kidnapped off the street just to be set free again—something terrible is coming.

As Daiyu feared, things take a turn for the worse—the rescued woman's youngest son committed suicide. But for a kidnapping and a suicide to occur to the same family on the same day smells of deviltry, but the police can't be bothered to investigate—so Daiyu has no choice but to get involved or risk allowing a killer to run free.

Can Daiyu and her friends unravel what's really going on before the case is closed forever?
